MEMBERS CARS.

After looking through our newsletter the other week it struck me that we never seemed to have any sort of technical stuff. So, to add some more interest to our interests in Rovers I took it upon myself to start something about our own vehicles within the Club. If all goes well I hope to keep this going every now and then, and will probably pounce on some unsuspecting person when they least expect it. However, if you would like a mention, then just send me or one of the committee members the history of your car and as much detail as possible, and we will make you famous.



To start this month ANDY SMITH was cornered to reveal all. Those who have seen his vehicle of late must agree that this vehicle is in very nice condition. The car itself is a P5B saloon registered LGF 492 K of 72 vintage. Andy bought the car from is last owner in Guildford for £500 back in August 82 and since then has had some quite eventful happenings.

The car was originally bought by A and B Plating in London as a company car and had 2 years ownership before passing to another company as a chauffeur driven hire car. Two years later the car finally passed into private hands who was its last owner before Andy and was stored for the last 3 years of his ownership.

During Andy's ownership the car managed to break down in the first hour of trying to return home; this was because of too rich a mixture. So far the car has had a completely new gearbox, starter motor, fuel pump and an oil seal in the back axle.

When Andy first had the car it was a two tone paint scheme that was not original, but now I am pleased to say it has original Rover colours of silver birch base with burnt grey sides. And very nice it looks too. Incidentally, the paint work was done by a Rolls Royce trained person, so you see what I mean by 'nice'. The interior is brown leather and Andy has managed to maintain part of the original tool kit, also the proper Rover radio. The only unusual point is the carburettors. When you first look there are no float chambers, until you realise they are emission control SU HF6s and have the float chambers combined. The only misshap was when the brake pipe split on the MOT ramp.

For the future Andy intends to sort out the windscreen leak and insists the rear wings need to be replaced. All in all, a very nice and presentable Rover that I feel we will see at many more shows and rallies.

Recently, Andy has removed and rebuilt the engine, crank regrind, big ends, cam shafts and followers, tappets; in fact, the whole lot. He completed this mammoth task in about 4 weeks, with help from Roger Pattie. So, if anyone wishes to know about engines!!!!

HANTS AND BERKS ROVER OWNERS.

1. TITLE. The name of the Club shall be "H.B.R.O." herafter referred to as "the club".

2. OBJECTS:

- a) to further interest in motoring and motor sport,
- b) to provide members with information, advice and assistance on matters connected with motoring and motor sport,
- c) to watch the local administration of the laws and regulations affecting motoring and motor vehicles, and to report any proposed local action or scheme to the RAC MSA Ltd.
- d) to promote motor competitions in accordance with the Rules of the RAC MSA Ltd.
- e) to arrange tours, lectures, discussions and social and other meetings,
- f) to afford members such benefits and privileges as it may be possible to arrange.
- 3. CONSTITUTION. Ladies and gentlemen of not less than (17) years or age shall be eligible for membership. The membership shall consist of (a) Life members, (b) Honorary members, (c) Ordinary members, (d) social members.
- 4. MANAGEMENT. The authority and responsibility for the transaction of the business of the Club for its management shall be vested in a committee, who, in addition to the powers and authorities by these rules expressly conferred on them, may exercise all powers and do all acts in furtherance of the objects for which the club is established, other than those hereby expressly directed or required to be exercised or done by the club in General Meeting.
- 5. ELECTION OF OFFICERS. Chairman, Treasurer, Secretary and Committee shall be elected at the Annual General Meeting and, subject to termination of office by resignation at the next Annual General Meeting following their appointment. The committee shall have power to co-opt other members as they deem necessary. The retiring officers and other members of the committee shall be eligible for re-election.
- 6. COMMITTEE. The committee shall consist of not less than four and not more than (8) members, exclusive of the Chairman, Treasurer and Secretary, who shall be ex-officio members of the committee.

Nominations of candidates for election to the committee may be taken at the AGM.

The committee shall have the power to appoint a sub-committee of not less than three persons to meet on its behalf in respect of any matter which is specifically referred to such a sub-committee.

- 7. MEETINGS OF COMMITTEE. The Secretary either of his own accord or by the direction of the Chairman shall unless otherwise agreed by all the committee give at least 7 days written notice of a meeting
- 8. ABSENCE FROM COMMITTEE. Any member of the committee who shall, without sufficient reason, absent himself from three consecutive committee meetings may be called upon to resign his position upon the committee.

- 9. DUTIES OF SECRETARY. It shall be the duty of the secretary to attend in person or by deputy all meetings of the club and all meetings of the committee, and to take minutes of the proceedings. Such meetings shall be entered in a book and presented for confirmation at the following meeting.
- 10. BANKING. All monies of the Club shall be banked by the Treasurer in the name of the club, and no disbursements shall be made therefrom except in accordance with the form or forms authorised by the committee.
- 11. ELECTION OF MEMBERS. Applications of candidates for membership of the club shall be submitted to the committee by the secretary, and the election of such candidates shall be at the discretion of the committee. The name and address and description of the candidate and the names of his proposer and seconder, being members of the club, shall be stated on each application submitted to the committee, provided that in the case of a candidate who knows no member of the club, the committee shall be empowered to carry out the election after proper enquiries.

Membership of the club shall continue only for the period covered by the current subscription, and members shall be subject to reelection annually by the committee.

All applications must be made by an individual in his own correct name and be signed by the said applicant personally.

- 12. MEMBERSHIP OF ANY OTHER CLUB. If a candidate is a member of any other club or organisation he shall not be entitled to affiliated membership, honorary, social or otherwise, either free or at a reduced rate.
- 13. PROVISIONAL MEMBERS. Any candidate for membership of the Club whose subscription has been accepted by the secretary shall become a provisional member of the club. Provisional membership of any candidate shall only hold good until the meeting of the committee next after payment of the subscription of such candidate.
- 14. VOTING OF COMMITTEE MEETINGS. Each member present at a meeting of the committee shall be entitled to exercise one vote. The committee shall vote by ballot if any member present so demands. A vote of one third against any applicant for membership shall exclude from membership.

No collective voting shall be allowed nor shall any proxy voting be accepted either individually or collectively.

- 15. SUBSCRIPTION. (
- 16. PAYMENT OF SUBSCRIPTIONS. Payable 1st November each year. Full rate applicable up to 8 months of full year, if only 4 months of year left then one third of full year subscription payable.
- 17. NEW MEMBERS. Any member who has been notified of his election and who fails to pay his subscription within one month of such notification shall be again requested in writing by the secretary or treasurer to pay the same, and if he fails to make payment within 14 days therafter, his election shall be ipso facto, null and void. No newly-elected member shall be entitled to any of the privileges of membership until after the payment of his first subscription.

- 18. NON-PAYMENT. Any member of the club who has not paid his subscription within two clear months of the date on which it became due shall be notified of the fact in writing by the secretary or the treasurer, and one month thereafter any member who has still failed to pay his subscription may, unless sufficient reason be shown to the satisfaction of the committee, be taken off the Register of members forthwith. No member whose subscription is in arrear shall be eligible to take part in any competitions organised by the club and the rules of the RAC MSA.

 19. RESIGNATION. Any member wishing to resign his membership shall
- 19. RESIGNATION. Any member wishing to resign his membership shall give notice in wriging of such desire to the secretary on or before the date on which his subscription would have become due for renewal in any year, otherwise he shall be liable to pay his subscription for the ensuing year. Also any member ceasing, voluntarily or otherwise, to be a member of the club, shall thereafter cease to have any claim upon the property of the club or to enjoy any privileges of membership, but he or she shall remain liable for the payment of any debts due to the club from him or her.
- 20. USE OF CLUB NAME AND ADDRESS. The name and address of the club shal not be given by a member as his address for trade, advertising or business purposes or in connection with any legal proceedings.
- 21. LIFE MEMBERS. Subscribers of not less than (10) times the annual subscription for the time being may be elected Life Members by the committee, and shall be exempt from the payment of annual subscriptions. A member cannot become a Life Member until after reelection.
- 22. EXPULSION OF MEMBERS. It shall be the duty of the committee if at any time they shall be of the opinion that the interests of the club so require, by letter to invite any member to withdraw from the club within a time specified in such letter, and in default of such withdrawal to submit the question of his expulsion to a meeting of the committee to be held within 6 weeks after the date of such letter. Members of the committee shall be given at least 7 days notice that a question of withdrawal or expulsion is to be discussed at a meeting of the committee. The member whose expulsion is under consideration shall be given at least 7 days notice of such a meeting and shall be allowed to offer an explanation of his conduct verbally, or in writing and if two-thirds of the members present shall then vote for his expulsion, he shall thereupon cease to be a member of the club.
- 23. THE ANNUAL GENERAL MEETING. The Annual General Meeting of the club shall be held in the month of October in each year upon a date and at a time to be fixed by the committee. The Annual General Meeting shall:
 - a) receive from the committee a full statement of accounts duly audited showing the receipts and expenditure for the year ending
 - b) receive from the committee a report of the activities of the club during the said year.
 - c) elect the Chairman and the Secretary and Treasurer of the Club and two auditors.
 - d) elect the committee.
 - e) settle any remuneration for the officers of the club.
 - f) decide on any resolution which may be duly submitted to the meeting as hereinafter provided.

- 24. SPECIAL GENERAL MEETING. A Special General Meeting may be convened by direction of the committee, or on a requisition to the secretary stating the business for which the special general meeting is required and signed by not less than 12 members. If the meeting so requisitioned is not convened within 21 days, the said 12 members may convene such meeting. Fifteen members shall form a quorum.
- 25. AGENDA. When members wish a matter to be discussed at a general meeting the text of such matters signed by at least two members shall be sent to the secretary at least 14 days from the date of such meetings so that it may be included in the Agenda.

A copy of the agenda shall be sent to each member at least 5 days prior to the meeting, but the fact that any member has not received a copy of the agenda shall not invalidate the proceedings. No business which is not included in the agenda shall be discussed at the meeting unless every member present is in favour thereof. Should the proposer of any motion fail to move a resolution in respect of the relevant item on the agenda, then any other member shall be entitled to do so.

- VOTING. Every person with a right to be present may exercise one vote. The Chairman shall not vote except in the exercise of a casting vote. At all general meetings, except as provided in Rule 30, a majority of votes decides a resolution. At any general meeting any 12 members may demand a poll, and thereupon the meeting shall be adjourned to a time and place to be named by the chairman, and a postal vote shall be taken of all members of the club. The decision of the members, as shown by such postal vote, shall be reported to the adjourned meeting, and shall be deemed to be the decision of such meeting. The Rules relating to collective voting and proxies shall apply as in Clause 14 hereof.
- 27. RIGHT TO BE PRESENT. No one can take part in general meetings unless he has been duly eleected as a member of the club, and had paid his subscription according to these rules.
- 28. OBSERVANCE AND INTERPRETATION OF RULES. Every member binds himself to abide by the rules of the club, and also by any modificiations thereof made in conformity with such rules, and also to accept as final and binding the decision of the committee in all cases of dispute or disagreement as to the interpretation of these rules.
- 29. ALTERATION OF RULES. Amy alterations may be made in these rules by a general meeting provided (a) that details of the proposed alteration or alterations are included in the notice of the general meeting and (b) that the resolution proposing such alteration is carried by $\frac{2}{3}$ of those present and voting at such general meeting or by $\frac{2}{3}$ of those voting shoult a poll be demanded as provided for in rule 27.
- 30. EVENTS. All motor competitions organised by the club shall be held under the rules and requirements of the RAC MSA Ltd. Any member convicted of an offence arising out of his being in charge of a motor vehicle in any club event or on club business shall thereupon be liable to expulsion from the club under rule 23.

31. COPIES OF RULES. Every member shall be furnished with a copy of the club rules and regulations on election.

32. BADGES. Any badges issued to a member by or for the club shall remain the property of the club. On termination of their membership, members shall deliver up such badges to the secretary.

33. DISSOLUTION. The club may be dissolved by a special general meeting convened by direction of the committee, or on the requisition of the majority of the members. If the resolution of dissolution by duly passed, the committee shall forthwith liquidate the affairs of the club and if there be any surplus assets on realisation, these shall be disposed of at the discretion of the committee.
