RACMSA OR NOT??

There has been much discussion about the fact that the ARC now has the authority to issue "Exemption from Prosecution Certificates" for motor sports events. So a referendum was decided upon to decide whether the ARC should stay with the Royal Automobile Club Motor Sports Association (RACMSA) or whether to "go it alone". The following information was sent out on the 19th December 1992 but was not made available to me for publication until 3rd Feb. 1993. The intention was to provide the club's members with this information and for them to respond with a decision. The ARC Council have requested a response to the referendum by the 19th of February for their Council meeting. That will have taken place by the time you read this so the HBRO will not have responded to that request other than to have given the Committee's opinion

What follows is copied from information circulated by the ARC. (There are a few factual errors that I have commented upon.)

Background Comment

The referendum of the ARC member clubs has been called for following action by the Royal Automobile Club Motor Sports Association in changing the ways that Cross Country Motor Sport operates. The basic changes are in event permit categories and that Competition Licences are required for certain events.

The MSA originally wanted to introduce universal licensing some years ago. This would have happened had the ARC not introduced individual memberships. This latest attempt followed consultations between the MSA and HM Government over the wording of new legislation. At first the MSA claimed that the government required universal licensing but investigation into this showed that the MSA was putting forward what appeared to be well worded misinformation. Despite being confronted with their misinformation, the MSA wouldn't (or couldn't) accept that they were wrong in both the intent of the Act and the information they were promulgating.

Following a meeting earlier this year with the chief executive of the MSA, it was decided that the ARC should further the idea of leaving the RACMSA. Initially, the concept was to form an association with all CCV clubs, the Cross Country Motor Sports Agency (CCMSA), however it was realised that the concept of Rover Club CCV eventing is different from the non-Rover marque clubs and that with a joint venture there could be constant bickering between clubs and an erosion of safety standards, an area which the ARC leads.

It is appreciated that ideally every member of the ARC should be consulted, however, the logistics and costs involved make this impractical. Additionally, it had been a basic presumption that a club committee is more knowledgeable about MSA operation and are more likely to make an informed decision rather that express a gut feeling.

The results of the referendum will make it possible for an ARC decision to finalise independent operations away from the MSA or to place the separation proceedings on hold should they be required in the future.

The ARC is committed to form the CCMSA in any event, to oversee and run the exemptions from prosecution that the ARC can issue under the Motor Vehicle (Off Road) Event Regulations.

When you see the two options, you will note that there is no half way step, there is no half in, half out. Whatever direction we take for the future, it must be taken confidently and with the knowledge that it is the right move at the right time. The MSA is a tried and tested organisation, whatever its faults, it works. Occasionally it works against us, on this occasion it may have loaded the camel's back with too many straws.

The final thought on separating from the MSA is that the new body will have to perform similar tasks to that currently done by the MSA. in 10 years time, will the cross country motor sports agency be looked on in the same way we currently look at the RACMSA - be that good or evil?

The RACMSA View

The RACMSA is the government and FISA (Federation Internationale de Sport Automobile) appointed body to govern all motor sport in the UK. This enables us to have an input into legislation affecting motor sport and have recently appointed a Parliamentary Intelligence Group to monitor future legislation.

By having a competition licence you will also receive a copy of the RACMSA yearbook which covers the rules governing your sport for both competitors and organisers. For many, this is the only opportunity to see the rules for your branch of sport and see how it is governed.

You can use your competition licence to move from CCV sport to any other form of motor sport.

The MSA provided a judicial body for formal complaints and ensures fair play for all, whether organisers or competitors.

The MSA provides a united front for motor vehicle users against the anti-motor sport lobby.

The insurance cover provided for CCV eventing is cheap and very flexible in its approach, yet provides good cover.

The MSA provides a united body for CCV eventing.

The MSA has, despite many complaints, treated CCV eventing fairly and has allowed much flexibility that is not given to other forms of sport; roll-

bar designs *(See note 1) are one aspect, the way the ARC is allowed to run a national status event as a Closed-to-Club *(See note 2) is another. (ARC National)

Which events require which permits/licences?

Any higher grade of licence acts as a lower grade.

Editor's comments - Without wishing to direct member's opinions one way or the other, I must point out that:-

(Note 1) This isn't flexibility, it's a clearly stated rule in the RACMSA Yearbook that the ARC and the AWDC can use their own designs of roll-bars. This is allowed because the RAC's own range of designs are not suitable for Cross Country Events.

*(Note 2) Because the ARC is an RACMSA affiliated club in its own right and any member of an ARC affiliated club is a member of the ARC, then any ARC members can participate in a National event run as Closed to Club.

Why Go Independent?

The first thing to note is that this has not been titled "The ARC view" - this has been done deliberately as the choice has yet to be made! Neither is it a full explanation of what has happened, this would take up far more space than that which can be allotted here.

An opinion of MSA actions in their dealing with the CCV world of late is that they have been devious and deceitful, even down to the forming of the Cross Country Committee, whose chairman, following MSA appointment, has now changed his stated view of being against the MSA in their actions to one which now supports them.

Consider also, now the MSA has dragged us into their arena of licences etc., how long will it take them to make us <u>fully comply with the Blue Book?</u> *(See note 3) Bear in mind everything is in there, the additional pre and post event paperwork, the additional organising and the changes to events, even down to the way they are scored.

Basically, the choice is between being run by a body of people who know Rover Club eventing, what we want, how our level of sport operates, how our members want a low key day out for the fun of it - or being run by a body of professional motorsports organisers, the majority of whom have never even seen a CCV event.

It is a choice between keeping the sport at a low cost level, operating it for the man in the street, providing a good day's sport for the guy who uses his Rover on a day to day basis or, moving into the high cost arena of having one vehicle for trials, another for comps, paid officials, scrutineers and stewards appointed by the MSA, taking everything on trailers and paying for it.

It is a choice between having regulations which suit Rovers or regulations which have to cater for cut down Volkswagens, beach buggies and home-made cut down bedsteads fitted with caterpillar tracks.

It is a choice between letting CCV eventing remain as it is or be priced out of the market.

It is the choice between being run be people we elect to do the job or being run by people who dictate to us.

It is the choice between self determination and control or, letting ourselves be led and taxed (or charged) by the RACMSA.

(Note 3) Editors comment - Without wishing to direct member's opinions one way or the other, I must point out that we already do <u>fully comply with the Blue Book</u>. I have mentioned this too many times to count. The ARC regulations are in addition to the RAC Yearbook. Any differences from the norm are permitted by SRs or by direct statements within the yearbook.

What the ARC Can Do

Currently Tony Holder is conducting an in-depth feasibility study to ascertain if wholly independent operation is viable. If it reveals that the price of freedom is too high, we will have no option other than to stay with the MSA. Initially, costs will be high, there can be little doubt of that, the insurance premium will be horrendous, the setting up of an admin. system to cater for some 250 events will be a nightmare BUT it can be done.

It can be done if YOU have the will for it to be done, the ARC will need closer co-operation from the clubs, clubs will have to be closer to the ARC, we are after all, only ordinary club members.

- 1. We can get insurance at comparable rates to those quoted by the MSA.
- 2. We can issue Exemption from Prosecution Certificates and are listed by the Government to do so.
- We can issue event permits for Off Road Events etc., should you decide that you want them (They are not a legal requirement, just a piece of paper with a title so you can be charged for them.)
- 4. We can, if YOU wish, issue event regulations, vehicle regulations etc. (See note 4)
- 5. We can replace the judicial body the MSA currently runs.
- 6. We can be represented in the same manner as the MSA at Parliamentary approved meetings to represent CCV users.
- 7. We can do everything the MSA can if you want us to. It is pointless trying to gain independence if you don't want it.
- * We cannot issue permits for events held on public roads.
- ** We cannot currently issue acceptable licences for competitions held abroad.

(Note 4) When a Certificate of Exemption from Prosecution is issued, the Road Traffic Acts no longer apply. A replacement set of regulations to cover all eventualities will need to be supplied. In the case of the RACMSA, these are to be found in the RACMSA Yearbook. The CCMSA will have to provide an equivalent set. (Editor.)

Even though we have missed the official date to convey our thoughts on this important matter, please let me know what your opinions are. I may be able to bring up some of your comments at the ARC AGM.



Please come along on Saturday to help lay out. On the Sunday, please enrol as a marshal once in a while; we'll show you how to score if you've not done it before!



The WotR is a winching / map-reading / initiative / stamina test that lasts for about seven hard-working hours. The "War" is run by the Red Rose Land Rover Club. It is now open to any ARC club, having started out as I expect you can guess, as a competition between Lancashire and Yorkshire clubs. It is now held in Cumbria!

The date is the long weekend of the 9th to 12th of July. There is an RTV on Saturday 10th followed by the main event on Sunday 11th. I wasn't asked to detail the team so if you want to have a go, let me know. Cost is £18 per vehicle and we need three vehicles each with two crew to make up the team. So that's only £9 per person for a long, well designed event. Winches are essential on at least two of the three vehicles. Steve Kirby has a complete Fairey engine-driven drum winch and fitting kit for a Series I, II or III LR that can be loaned for the occasion if you have a suitable vehicle but no winch. Any ARC legal vehicle will do. If you can't compete, just come along to watch anyway. It's great entertainment. The RTV on the Saturday is open to any ARC member.

Dear Gary,
