As mentioned last month, Section H, Off Road, has undergone major changes, Further to my respose to Dave Cuthbert's article, the new rules seem to clarify the matter. (or at least put them another way!)

H.26.3.2. states that "The boundaries of an observed section may be indicated by markers..." and H.26.3.9.(b) states that a penalty will be incurred when "All the wheels of the competitor's vehicle cross the boundary of the course as defined by the Clerk of the Course." This shows that the CoC may define the boundaries to be wherever he/she wants them to be but must, presumably, mark them clearly.

Note too that following the sale by the RAC of its recovery services; the RACMSA is now to be known as the MSA. It also has a new logo which is shown below.

KEEPING LAND ROVER THE WAY IT WAS BUILT

Production Standard Regulations.

Introduction.

There follows the provisional version of the Production Standard Regulations. They will apply to RTV trials and Competitive Safari, initially. The planned introduction programme will be as follows.

- Run on a test basis alongside the existing rules throughout 1999. i.e. they may be used as an alternative / additional set from Jan 1st 1999.
- Discuss any changes and future implementation during 2000
- Replace existing rules with this new set from Jan 1st 2001.

A production vehicle is defined as a 4WD model having been produced in quantities of not less than 500 per annum regardless of engine capacity. It must have been available through a dealer network plus the MoD and must be to standard European

specification, as detailed in the vehicle's handbook. It is the competitor's responsibility to provide the evidence if required, of the vehicle's eligibility.

No modifications not expressly authorised below, except those necessary to comply with Safety Regulations, may be made to the vehicle

A ENGINE

- 1. The accelerator cable may be replaced or doubled with or without parts from the original manufacturer.
- 2. The make and type of spark plugs are free, as are rev. limiters and high tension cables and the ignition coil, where fitted.
- 3. The capacity and origin of the cooling system radiator / tank is free, as is the type of thermostat which may be removed. The original location and attachment points of the series production radiator must be retained.
- 4. Those parts of the carburettor or fuel injection system which regulate the admission of fuel to the engine may be modified, provided that the modification has no influence on the admission of air. The original fuel injection system must be retained, the injectors may be changed for injectors which are identical except for the size of the nozzle hole at the end.
- 5. The air filter, its housing and the tube between the housing and the atmosphere are free, but the housing must remain in its original location, the air must not be taken from the cockpit, modifications must not affect the structure of the car, and the installation must be situated entirely within the engine compartment. The air filter element may be removed.
- 6. The valve springs and valve clearance are free but the camshafts (including their profile) must remain as original.
- 7. The fuel pump is free, in operating principle, number and location outside of the cockpit.
- 8. The material of the engine mountings are free, but the number and location must remain as original.
- 9. The exhaust system after the first silencer is free except that it may not be replaced with a system of a larger diameter than that fitted upstream of the first silencer. The exhaust system must retain the original number of silencers, although additional silencers may be fitted. It shall be permissible to alter the exit point of the exhaust system either to the rear or sides of the vehicle providing that no alteration to the bodywork is made and the installation respects Construction and Use Regulations.
- 10. Where fitted the Cruising Speed Controller may be disconnected.
- 11. Sound-proofing panels may be removed.

B TRANSMISSION

 The clutch disc is free, including its weight, except for the number of discs and their diameter.

- 2. Standard transmission ratios must be retained. Optional extras are prohibited.
- 3. Locking and limited-slip differentials or traction control devices are permitted only if available as a standard fitment.

SUSPENSION

- Springs shall be the same type as those fitted as standard for the vehicle concerned.
 - (a) COIL SPRINGS: The length, diameters external and of the wire, the form of the spring platform and the type of spring (progressive or fixed rate) are free.
 - (b) LEAF SPRINGS: Shall not have less than 5 leaves except for 101" wheelbase Forward Control Land Rovers must have at least two leaves on each spring.. In addition, the second leaf should wrap around the eye. If the springs have been rebuilt, the leaves below the top two must be in proportional reducing steps to copy the originals. "Tin foil" or "Spacer" designs are not acceptable.

2. SHOCK ABSORBERS

- (a) Are free, but the type, telescopic, lever etc. and operating principles (hydraulic, friction, etc.) must be retained as original.
- (b) Gas filled Shock Absorbers will be regarded as hydraulic in respect of their operating principle.
- (c) The mountings must be retained as originally fitted and may not be reinforced.
- (d) It shall be permitted to fit an additional shock absorber at each wheel station, provided that the mounting's only purpose is the fitting of the additional shock absorber. (Comp Safari only)
- (e) The fluid tanks for the shock absorbers may be attached in the wheel arches as well as to the chassis.
- (f) Suspension travel straps are permitted.
- 3. RIGID AXLE Where fitted, the original; casing may be strengthened provided the original part can still be recognised.

D WHEELS AND TYRES

- Wheels and tyres are free provided that they remain covered by the original bodywork, including wheel arch extensions where originally fitted, and where no modifications may be made to the bodywork to permit their fitting. Studded tyres are prohibited. ARC tyre regulations apply.
- 2. The spare wheel may be relocated inside the vehicle provided that it is securely restrained and does not impinge on the space reserved for the crew.
- 3. Wheel fitting by bolts may be changed to stud and nut fittings.

E BRAKING SYSTEM

- The brake linings are free as is their mounting to the backing plate (riveted, bonded etc.) provided that the contact surface area of the brakes is not increased.
- 2. Protection plates may be removed or reshaped.
- In the case of a car fitted with servo-assisted brakes or an anti-locking device, this device may be disconnected. The same applies for anti-lock braking systems.
- 4. Brake hoses may be changed for aviation type lines

F BODYWORK

1. Exterior

- (a) Hub caps must be removed.
- (b) Protective headlight covers may be fitted provided that their only function is to cover the glass, and they may have no influence on the car's aerodynamics.
- (c) The fitting of underbody protection plates is permitted provided that their only function is to protect the following parts:- engine, radiator, suspension, gearbox, tank, transmission and exhaust.
- (d) A nudge bar may be fitted, in addition to the bumper, and must be independent of and not reinforce the car's structure or contribute to its stiffness. This bar must be made of tubes and may be mounted to the original bumper or chassis and may only be so constructed so as to provide protection to the headlights and provide mountings for auxiliary lights.
- (e) The side and rear windows behind the driver may be replaced with non-transparent material; or transparent material of at least 3mm in thickness. Openings originally made up of a number of panes may be replaced with a single pane or panel. The fixation: and mechanisms of these windows and those of the windows in the side doors are free.
- (f) The glass panel of the sunroof must be replaced with a panel of the same material as the roof of the car and must be at least 1.5mm. Not applicable to RTV.
- (g) The locking system for the cap of the fuel tank is free.
- (h) Where an externally mounted spare wheel is relocated inside the vehicle it shall be permitted to remove the original external wheel mounting
- (i) External rear view mirrors, and front and rear windscreen wipers are free.
- (j) Only winches, which require no modification to the structure of the car other than to facilitate the attaching of the winch by bolts, may be fitted.

2 INTERIOR

11

- (a) All accessories which have no effect on the car's behaviour are allowed without restrictions, such as those concerning the aesthetics or interior comfort (lighting, heating etc.) on the express condition that they do not influence, even in a secondary manner, the efficiency of the engine, steering, strength, transmission, braking or road-holding.
- (b) All the passenger seats, if occupied, must be fitted with head restraints. Not applicable to RTV.
- (c) The carpet behind the front seats may be removed when an FT3 tank is fitted in that area.
- (d) All the controls must be those provided by the manufacturer and they must retain their original function, but may be modified to improve their ease of use (extension handbrake lever, additional flange to brake pedal etc.)

The following are allowed in particular:-

- (i) Additional measuring instruments, counters etc. may be freely installed provided that they do not present a danger.
- (ii) The horn may be changed, and an additional one fitted which may be operated by the passenger.
- (iii) The mechanism of the handbrake lever may be modified to fly-off operation.
- (iv) The seats occupied by the crew are free, and the seat supports may be strengthened.
- Additional storage compartments may be added to the glove compartment and front doors.
- (vi) The steering wheel is free.
- (vii) Electric window mechanisms may be converted to manual operation.

G REINFORCEMENTS

- I. Strengthening of suspended parts is permitted where the strengthening material follows the shape and is in contact with the suspended part.
- It is permitted to fit strengthening bars to the suspension points on the bodyshell or spring mounting points, provided that the bars are attached by bolts and are removable. It is permitted to make holes in the suspension trim to attach the bars.
- 3. When the spare wheel is originally located within an enclosed space it shall be permissible, when carrying a wheel wider that that originally fitted, to remove the cover and or sufficient material to allow the wider wheel to be carried within the space provided.

H ELECTRICAL SYSTEM

- 1. The battery and associated cables are free, save that the battery must be located in it original position using the original mountings.
- 2. The alternator is free.
- 3. Fuses may be added to the electrical system.
- 4. A maximum of 2 auxiliary forward facing lights, and their associated relays etc. may be fitted, but which may not be fitted within the bodywork. Additional reversing lights may be fitted which may be operated only when reverse gear is engaged. In all other respects the lighting system must respect current legislation.

FUEL SYSTEM

Where an FT3 tank is fitted, fuel lines must be replaced with the aviation type. Where the original tank is retained it is permitted to change the fuel lines to the aviation type. It is further permitted to feed the original tank from the FT3 tank provided that the breather pipe passes through the FT3 tank. In all cases the routing of fuel lines are free except that they may not be routed inside the roll cage or chassis members.

JACK

The jack is free and the jacking points may be changed for others which have no other function.

NOTE:-References to an FT3 tank relate to bag-tank specifications.

Some Observations on the above rules:- ==

This set of regulations is just the start of an ongoing programme to revise the ARC vehicle regulations over the next few years. Other organisations are also adopting very similar rules which emanted from the MSA. So you should be able to go to an AWDC event and compete on much fairer terms than before (I nearly said "compete on a level playing field" but decided not to!) Bear in mind the statement in the ARC Policy Document a couple of years ago that said that no existing vehicle would ever be barred.

The effect on RTV will be quite small from the vehicle's point of view although the classes have been revised. The effect is far more dramatic for Comp Safari vehicles which must now retain the full silhouette of the vehicle which were previously allowed to be cut down to the waist-line.

- 10i) Shows and Displays. June and Jack Green.
- The Exhibition Unit is now booked for all the Bank Holidays In 1999! It is always pre-booked for the National Rally. It's based in the midlands. It weighs 2½ tons and will need a 110 or bigger vehicle to tow it safely.

- Fuel injection rule proposals have been vetoed by the Council. Objections raised from the floor as to where in the rules / constitution they had the right to do this. Surely the membership have the right to vote on any rules proposed?
- Production Standard Regulations. These were presented as a rule change proposal by the Scrutineering Committee. The Council reviewed these and decided to allow them to be used on a trial basis during 1999 to see how well they worked. Any changes would be discussed during 2000 for possible implementation in 2001 when they would replace the existing Standard Class rules.

lan Davis, Off-Road Executive and Competitions Department Manager, Motor Sports Association.

lan first answered questions sent in by ARC Club members:-

- 1) What can the MSA offer the non-competitive car club?
 - Your fee gives you unlimited exemptions for non-competitive events, gymkhanas, treasure hunts, Concours, Economy Runs, etc. The exemption gives you insurance. If you can get insurance cover cheaper than that, then get it elsewhere.
- 2) Do we need to be members to participate in Promotional events

 This is a structured event and can include trials-type sections but it must be marshalled. MSA rule B.5.1. says that the public may participate but not officiate. The idea is to capture new members and to show how events are run better than "cowboy" organisations.

 MSA regs (H.35.2.) state that drivers must already be members.
- 3) TYRO Trials. Why the restrictions? Why seat-belts?
 - RTVs started to get hard (there are no laid down specifications as to how easy or hard they should be) so it became evident that there was a need for a true beginners trial twixt RTV and Promotional. So a strict set of guidelines was written in such a way as to prevent the event being difficult; to stop the boundaries of performance being pushed too far! The rules allow the whole family to be in the car on the trials sections. The seat-belts were enforced because there had been a couple of accidents in Promo events with unsecured passengers so it was decided that all occupants should be belted-in regardless of whether this is a requirement for the public roads or not.
- 4) Seat belts in not required by law but are specified by the ARC for trials. Why? It's an ARC rule, not an MSA one.

- Safari / Scenic Drive with non-members in non-Rover vehicles.
 Non-Rover vehicles are OK but they must have membership card.
- 6) HarmonIsing regs for Standard Vehicles.

Sport is evolving at all levels. ARC members are able to participate outside the ARC and need to do so on even terms.

7) New Timed Trial Regs?

The original MSA regs are very old and describe a rough-ground sprint where the fastest vehicle wins; hence high insurance costs. The ARC does it differently; basically a trial that is timed. Average time is set to be half that of a Comp Safari. The Off-Road Committee are happy with it now. Implementation due in 2000. The intention is to talk down the insuramnce costs. Trials will be 350 yards / 1/5th mile long.

8), Safety Helmet Changes.

From 2000, BS6658 type A no longer usable. Restickering will take place due to logo change. Current Gold sticker will be invalid from 2001. Blue sticker will be only one acceptable after that date. Lifing of helmets is a future possibility where helmets will be "hard-lifed", rather than be subject to inspection only for condition. If you buy a new helmet from now on, get a red label helmet to BS6658-85 type AFR.

- 9) National B licensing of Officials. Will all officials need to be licenced? Problems have come up and some have been from the ARC and some from other organisations. It's a matter of risk management - where there are problems, then the administering organisation must be seen to be making an effort to address the problems. Scrutineering problems have been brought to the attention of the off-Road Committee and shown the need for further improvement. Comp Safari is seen as the riskiest event and so Comp Safari scrutineers must be licenced.
- 10) Is membership of Regional Associations encouraged by the MSA?

 Yes. Clubs need to be a part of a local group. There is rationing of military land, for example and the regional group usually decide upon allocation of scarce resources. You also need to be a member of a regional group to be considered for Lottery money.
- 11) Will the ARC press ahead with the definition of RTV regulations?

 That's for the ARC to decide.

lan then raised some items of his own. Text in italics are questions / comment from the members.

Section H no longer makes references to sections M and K. The referenced paragraphs have been brought into the body of section H text which has changed substantially for '99. Live recoveries are not allowed in Comp Safaris. Actually they never have been but users of section H didn't seem to be referring to the live recovery rules in section K on Rallying. However, specific exemptions on this can be applied for (but don't count on them being granted). The MSA would like to create a set of regulations to cover live recovery, but in a controlled way.

Club Sport Category. See MSA 1999 Yearbook section B.4. This lists events for which SRs are not required. Off-Road Trials, TYRO trials and Gymkhanas come into this new category as far as the ARC is concerned.

The ARC's normal SRs are in the Handbook so could we submit a copy of this to the MSA and refer to it in our permits? MSA staff could then consult it if necessary.

Yes, that would be a good idea.

Rallies etc. shown on TV often show very bad examples of behaviour and management. For example, in the recent Rally of Great Britain, badly damaged vehicles were shown not only at speed on the sections but travelling on public roads. In one case, the police had to intervene. In another case where a vehicle lost a wheel and the navigator rode unsecured in the boot with the tailgate open. How can we be expected to control our events when the major international ones show such disgraceful goings on?

These event are run under FIA rules that allow this sort of thing and police in other countries turn a blind eye to this. It's also down to the Marshals and the Clerk of the Course to make a decision on the spot. But I agree, it sets a very bad example at a time when we are trying to set better standards.

Scrutineer Car - National B Off Road. Can you explain this please?

This is an interim position. In order to provide enough Scrutineers to cover the new Comp Safari requirements, we have come to this arrangement for a two year period. If you want to participate in the scheme, apply to Paul Gladstone at the MSA (01753-681736)

Driving Licences - why don't we inspect them any more?

The declaration that competitors sign when they sign on states that they hold a current valid full driving licence. The responsibility is with the competitor for making this declaration. If you have doubts or can prove that a false declaration has been made, then report the matter to the MSA who will discuss it at a tribunal. A false declaration is a serious offence. The Club Card constitutes a Competition Licence in the specified events.

but I suggest that inspecting that is quite acceptable.

Are there any other committees that ARC members can be represented on?

The MSA encourages more participation. The ARC can assist and influence the MSA by offering specific talents and latent abilities. Contact the relevant section members / manager of the MSA to offer your services.
