# CONSTITUTION

Issue 6

© HBRO 1998

- 1. TITLE: The name of the club shall be the "HANTS & BERKS ROVER OWNERS" known as the HBRO and herein after referred to as "the club".
- DEFINITION: In connection with the club, the term "ROVER" shall refer to vehicles produced by The Rover Motor Company, the Austin Rover Group (and their successors) and any company in between bearing the Rover name, differently badged overseas models and vehicles produced by the Land Rover Group.
- OBJECTS:-
- to further interest in motoring and motor sport.
- b) to provide members with information, advice and assistance on matters connected with motoring and motor sport.
- c) to watch the local administration of the laws and regulations affecting motoring and motor vehicles and to report and proposed local action or scheme to the MSA Ltd.
- d) to promote motor competitions in accordance with the rules of the MSA Ltd.
- to arrange tours, lectures, discussions and social and other meetings.
- to afford members such benefits and privileges as it may be possible to arrange.
- g) to assist and encourage members in the restoration , maintenance and use of Rover vehicles.
- 4 MEMBERSHIP: Ladies & gentlemen of not less than 14 years of age shall be eligible for membership. The membership categories shall consist of :-
- a) Honorary Members
- b) Ordinary Members
- Associate Members
- d) Social Members
- MANAGEMENT: The authority and responsibility for the transaction of the business of the club for its management shall be vested in a committee, who in addition to the powers and authorities expressly conferred on them by these rules, may exercise all powers and do acts in furtherance of the objects for which the club is established, other than those hereby expressly directed or required to be exercised or done by the club in general meeting.
- ELECTION OF OFFICERS: Chairman, Secretary, Treasurer and Committee shall be elected at the Annual General Meeting and, subject to termination of office by registration, shall remain until the next Annual General Meeting following their appointment. The committee shall have power to co-opt other members as they deem necessary. The retiring officers and other members of the committee shall be eligible for re-election.
- 7. COMMITTEE: The committee shall consist of the Chairman, Secretary,

Treasurer and not more than five other members. Nominations for candidates for election to the committee may be taken at the Annual General Meeting. The committee shall have the power to appoint a sub-committee of not less than three persons to meet on its behalf in respect of any matter which is specifically referred to such a sub-committee.

- 8. MEETINGS OF COMMITTEE: The Secretary, either of his/her own accord or by the direction of the Chairman shall, unless otherwise agreed by the committee, give at least seven days written notice of a meeting.
- 9. ABSENCE FROM COMMITTEE: Any member of the committee who is absent from three consecutive committee meetings without sufficient reason, may be called upon to resign their position from the committee.
- 10. DUTIES OF THE SECRETARY: It shall be the duty of the secretary to attend in person or by deputy, all meetings of the committee and to take minutes of the proceedings, such minutes shall be recorded and presented for conformation at the following meeting.
- 11. BANKING: All monies of the club shall be banked by the Treasurer in the name of the club and no disbursements shall be made there-from except in accordance with the form or forms authorised by the committee. However small amounts of cash may be retained by the treasurer for petty cash, provided the amount does not exceed 10% of the club funds.
- 12. ELECTION OF MEMBERS: Application for membership of the club by candidates shall be submitted to the committee. The application is to be accompanied by the appropriate subscription, which will be returned if the membership application is rejected and the election of such candidates shall be at the discretion of the committee. All applications must be made by an individual in his or her own correct name and be signed by the said applicant personally. Applicants for ordinary membership will, after election, become Ordinary members.
- 13. ASSOCIATE MEMBERS: An associate members is one who is:-
- a) The spouse or an ordinary member, or
- b) accepted as a special case by the committee.

Associate members may participate in club events, they have limited voting rights, and other than notice of renewal of membership, will normally receive no official correspondence.

- 14. SOCIAL MEMBERS: Social Members may attend club meetings and participate in club events as passengers, they have no voting rights and other than notice of renewal of membership, will normally receive no official correspondence. They must be personally known to an ordinary member of the club.
- 15. PROVISIONAL MEMBER: Any candidate for membership of the club whose subscription has been accepted shall become a provisional members of the club. Provisional membership of any member shall only hold good until the meeting of the committee after payment of the subscription of such candidate. Provisional members may participate in club events but have no voting rights.
- 16. VOTING BY COMMITTEE MEMBERS: Each committee member present at a committee meeting shall be entitled to exercise one vote. The committee shall vote by ballot if any member present so demands. A vote of one third against any applicant for membership shall exclude \* that application No collective voting shall be allowed. Proxy voting shall be accepted.
- 17. SUBSCRIPTIONS: To be decided at each Annual General Meeting.
- 18. MEMBERSHIP: Membership shall last for twelve whole months from

payment of subscription. However, Associate Membership shall be coincident with the relevant Ordinary Members.

- 19. NON-PAYMENT: Any member of the club who has not paid their subscription by the date it becomes due, shall be notified of the fact in writing and one month thereafter any member who has still failed to pay his subscription shall, unless sufficient reason be shown to the satisfaction of the committee, be taken off the register of members forthwith. No member whose subscription is in arrears shall be eligible to take part in any competitions organised by the club.
- 20. RESIGNATION: Any member wishing to resign their membership shall give notice in writing of such a desire to the Secretary on or before the date on which his subscription would become due for renewal in any year. Also, any member ceasing voluntarily or otherwise to be a member of the club shall thereafter cease to have any claim upon the property of the club or to enjoy the privileges of membership, but he or she shall remain liable for any debts due to the club from him or her.
- 21. USE OF THE CLUB NAME & ADDRESS: The name and address of the club shall not be given by any member as his address for trade, advertising or business purposes or in connection with any legal proceedings.
- 22. HONORARY MEMBERS: At the absolute discretion of the committee, a member may be elected and remain an Honorary Member and be exempt from payment of annual subscription for as long as the committee may decide. Honorary Members may participate in registered competitive club events with the written permission of the MSA Ltd. but will have no voting rights.
- 23. EXPULSION OF MEMBERS: It shall be the duty of the committee if at any time they shall be of the opinion that the interests of the club so require, by letter to invite a member to withdraw from the club within a time specified in such a letter and in default of such withdrawal to submit the question of his/her expulsion to a meeting of the committee to be held within six weeks after the date of such a letter. Members of the committee shall be given at least seven days notice that a question of withdrawal or expulsion is to be discussed at a meeting of the committee. The member whose expulsion is under consideration shall be given at least seven days notice of such a meeting and shall be allowed to offer an explanation of their conduct verbally, or in writing and if a majority of the committee members shall then vote for his/her expulsion, he/she shall thereupon cease to be a member of the club.
- 24. THE ANNUAL GENERAL MEETING: The Annual General Meeting of the club shall normally be held in the month of October in each year upon a date and at a time to be fixed by the committee. Three committee members together with fifteen ordinary members shall form a quorum.

The Annual General Meeting shall:-

- a) Receive from the committee a full statement of accounts duly audited showing the receipts and expenditure for the year ending.
- b) Receive from the committee a report of the activities of the club during the said year.
- Elect the Chairman, the Secretary, the Treasurer and the committee members of the club and two auditors.
- 25. SPECIAL GENERAL MEETING: A Special General Meeting may be convened by the direction of the committee, or on a requisition to the Secretary stating the business for which the Special General Meeting is required and signed by not less than twelve ordinary members. If the meeting so requisitioned is not convened within thirty-five days, the said twelve members may convene such a meeting. Fifteen

ordinary members shall form a quorum.

- 26. AGENDA: When members wish a matter to be discussed at a general meeting the text of such matters signed by at least two members shall be sent to the Secretary at least fourteen days prior to the date of such meetings so that it may be included in the agenda, together with matters which the committee wish to discuss. A copy of the agendas shall be sent to each member at least five days prior to the meeting, but the fact that any member has not received a copy of the agenda shall not invalidate the proceedings. Should the proposer of any motion fail to move such a resolution in respect of the relevant item on the agenda, then any other member shall be entitled to do so.
- 27. VOTING: Ordinary Members may vote at Annual General & Special General meetings. Associate Members may vote only at Annual General Meetings. The Chairman shall not vote except in the exercise of a casting vote. At all general meetings, a majority of votes except as provided in rule 30 decides a resolution. At any general meeting any twelve ordinary members may demand a poll and thereupon the meeting shall be adjourned to a time and place to be named by the chairman and a postal vote shall be taken of all ordinary members of the club. The decision of the members, as shown by such postal vote, shall be reported to the adjourned meeting and shall be deemed to be the decision of such meeting. The rules relating to collective voting and proxies shall apply as rule 16 hereof.
- 28. RIGHT TO PARTICIPATE: No-one can take part in general meetings unless he/she has been duly elected as a members of the club and has paid the subscription according to these rules.
- 29. OBSERVANCE AND INTERPRETATION OF RULES: All members bind themselves to abide by the rules of the club and also by any modifications thereof made in conformity with such rules and also to accept as final and binding the decision of the committee in all cases of dispute or disagreement as to the interpretation of these rules.
- 30. ALTERATION OF CONSTITUTION: Any alterations of the constitution may be made by a general meeting provided that the details of the proposed alteration or alterations are included in the notice of the general meeting and that the resolution proposing such alterations is carried by two third of those present and voting at such general meeting, or by two thirds of those voting should a poll be demanded as provided in Rule 27.
- 31. EVENTS: All motor competitions organised by the club shall be held under the rules and requirements of the MSA Ltd. Any member convicted of an offence arising out of being in charge of a motor vehicle in any club event or on any club business shall thereupon be liable to expulsion from the club under
- 32. Every member shall be furnished with a copy of the constitution on election.
- 33. BADGES OF OFFICE: Any badges of office issued to a member by or for the club shall remain the property of the club. On termination of his/her membership, members hall deliver up such badges to the secretary.
- 34. DISSOLUTION: The club may be dissolved by a special general meeting convened by direction of the committee, or on the requisition of the majority of the members. If the resolution of dissolution be duly passed, the committee shall forthwith liquidate the affairs of the club and if there be any surplus assets on realisation, these shall be disposed of at the discretion of the committee.

However, Nick is planning a totally different Safari Holiday. A self drive holiday, sleeping in a two man tent, self catering, no toilets, no showers, & wilderness camps. He was however, talking about doing it with a Company who have been organising this sort of adventure holiday for years. I would not have agreed to do something like this on our own. At first there was Shock, Horror!! Then slowly I became interested. We talked about it in the club, and others became interested and so it happened. Six HBRO club members Nick and I. Jean and Paul. Zoe and Kiran plus their delightful little girl Devika who celebrated her first birthday while they were away, joined a group of eight adventurers and a Photojournalist, on a Moroccan Safari in April this year.

#### THIS IS MY DIARY

#### SAT 10th APRIL (The Ferry.)

Nick and I awoke at 7 am. Very surprised we had both managed to sleep, as we were so excited. Nick packed the TDI Ninety during the day. As we said our goodbyes to the family and our dog 'Jet' (who was definitely not himself and was aware that something strange was happening) I got my first twinges of nerves, was I really doing this mad thing.

We left home at about 5.15 pm and made a stop on the way to the port to top up with fuel. We had arranged to meet Jean and Paul (HBRO Members) at the Portsmouth Ferry Port. As we turned into the Port we spotted Jean and Paul in their White Discovery. We both pulled up to the side of the road and waited to see if any others going on the trip had arrived or would soon arrive. We had only been there a couple of minutes, when a young couple came across and introduced themselves. A husband and wife, Keith and Sharon, driving a two year old Pewter coloured LWB Shogun 2.8 TD. (This was the only non Land Rover on the trip.) They had arrived in Portsmouth at Midnight on Friday night having come over from Jersey on a Cargo Boat. It turns out that Keith works for a shipping company and they had got a free passage over to Portsmouth. The Shogun on deck in a container while Keith and Sharon had a comfortable cabin with a shower and a TV. Sharon works as a Chef, so she was teased straight

away, being told she would be put in charge of cooking for the group. Before we boarded the Ferry, we had made contact with everyone travelling with group on the Portsmouth to Bilbao Ferry. All very nice. Once on board we all arranged to meet up for a drink in the bar to get to know one another. The group consisted of the couple from Jersey, Keith and Sharon, in their Shogun. A brother and sister Miles and Tara who had come over from Ireland the day before and had travelled down from Liverpool during the day. Miles was driving a Blue TDI Ninety Hard Top. Miles works on Land Rovers, as a civilian working for the Army. Tara is a nurse. Jim and Rita, a husband and wife team from Norfolk in a very well equipped White V8 110 County. This V8 has been used a lot in the desert. Jim and Rita have not long ago returned to the UK to live after living and working in Saudi Arabia for eighteen years. Both had a wealth of knowledge, and soon earned the respect of the whole group. Jim is not working at the moment, but Rita would like him to get a job so that he is not under her feet all day. I think Jim needs some kind of job to keep him busy. Then there was Tim, with his girlfriend Helen, from Nottingham, driving a Beige V Range Rover. He is a New Zealander who has lived and worked in the UK for eight years. His job is in publishing, and he is well travelled. Tim belongs to a Nottingham off-road club now, but it turns out he used to belong to the Twickenham Off-Roaders when he lived in London and knows Steve Kirby. His girlfriend Helen works as a manageress in a restaurant. They are expecting their first child. Of course the group at this stage is missing Kiran, Zoe and Devika (HBRO Members) who had caught the Ferry to France on Friday and were travelling down through France and Spain to meet us in Algeciras on Tuesday. We had also been told by Ray Monteith that we have a Photojournalist as a member of the group. He did not appear to be on the Ferry so was as yet unknown to us. After our drink, Paul, Jean and ourselves went along to watch the on board Show which was very good, before turning in.

#### SUN 11th APRIL (The Ferry.)

Neither Nick or myself had a good nights sleep. It was very noisy in our cabin. Thank goodness I remembered to pack the ear plugs, or I don't think we would have slept at all. We were both wide awake before 7am. I was feeling sea sick and had to take some travel sickness tablets. We went along to the cafeteria for breakfast. (A word of warning to anyone thinking of travelling on the Pride of Bilbao, all the food is extremely expensive) At breakfast a couple overheard our conversation and asked if we were with the Land Rover Group. It turned out that during the previous evening they had been talking to Jim and Rita. They had a Rag Top 110 and were very envious of us all. We had quite a long conversation with them. They had a boat in the south of Spain and they travelled over to Spain very regularly. After breakfast I felt a lot better. We went up onto the sun deck, the weather was lovely. Nick and I were both hoping to see Dolphins but we were out of luck. While we were up their we meet up with Jean and Paul and decided to go to the Cinema that afternoon. So we went and booked it. They have two Cinemas on board. We went to see Something About Mary. It was excellent, an adult comedy. Very funny. A meeting had been arranged in the evening for everyone to get together and discuss the way we would travel through Spain. Everyone was present except for poor Helen who was not at all well. She had very bad sea sickness. It was decided at the meeting that it would be too difficult to travel in a single convoy of six vehicles. It would be better to split into two convoys of three. We arranged to stop just outside the port and sort ourselves into two groups. We also decided to travel as far as we could down Spain on the first day, if possible getting to Granada to camp on Monday night. The friendly Brits with the Rag Top asked if they could join our group for a drink, they looked at the map with us and gave us advice on the route to take. After the meeting we had dinner and an earlier night as we had booked an early morning call for 5.30am on Monday morning.

#### MON 12th APRIL (Driving through Spain. Bilbao to Granada.)

The 5.30 call woke us, giving us time for a shower and breakfast before leaving the ship. We all gathered together waiting to disembark. Up to this moment, I had not felt I had left England. But as soon as we left the ship I knew. I was in another country. As arranged we pulled into the side of the road as soon as we could after leaving the port. We got ourselves into two groups of three. Paul and Jean leading our group, us and Miles in his Blue Ninety The groupings decided, we were about to drive off when the friendly Brits in the Rag Top tooted and drove passed. With that, Paul put his foot down deciding that this was too good an opportunity to miss, these people new the road very well. We followed the Rag Top round Bilbao, the traffic was very heavy, it was rush hour. Paul did an excellent job of keeping the Rag Top in his sight, it certainly made finding the correct routes easier. The guy soon realised he had a convoy behind him and his wife was keeping us in sight in her door mirror. We got clear of Bibao and after a while we realised we had gained two on the convey from the other group. Tim in the Range Rover and Keith in the Shogun but I could not see Jim in his White 110 anywhere. At this stage we had become a convoy of six, with the Rag Top at the front but minus Jim's 110. Once we had got well clear of Bilbao, we made a fuel and loo stop. When we pulled in Tim and Keith said they had lost Jim in the heavy traffic. However, it took a while for us to re-fuel and use the loo's and Jim managed to catch us up. He was watching out for us the whole time and saw us all in the service station. We re-organised ourselves before starting off again. We had four CB's between us and were now a convoy of seven vehicles with the Rag Top still in the front. We travelled on making good time. Paul keeping the Rag Top in sight all the time. Then Jean came on the CB saying the Rag Top was stopping for a coffee break. We all had a quick chat on the CB's and decided we would rather press on at this stage. So when the Rag Top pulled off we all waved and tooted our horns, they had been so much help. Now we are travelling in a convoy of six. We manage to stay together. Paul got us through Madrid without a hitch. (The friendly Brits had suggested we did not take the ring road but drive straight through the middle) We had a short lunch stop and decided we would definitely try for Granada. We arrived at the camp site just above Granada at 7pm having driven over 875k. Paul and Jean had done an excellent job. We were all very tired but pleased we had achieved so much. Tents up, we had a quick dinner and all went over to the club house for half an hour. It is so amazing how well we all get on. You would think we had known each other for years. (When we left the ferry this morning we put our watches forward an hour to Spanish time.)

#### TUES 13th APRIL (Driving through Spain. Granada to Algeciras.)

We were awoken early by the birds dawn chorus, it was very loud. However we drifted back into sleep again. It was a leisurely start to the day. Everyone waking up in their own time. Nick and I had a cooked breakfast before packing up the tent. I had a shower, there were two temperatures Cold and Bloody Cold. The Ninety was packed and we set off again. Nick taking the lead. We made excellent time until we met our first road works of the trip, this was just past Malaga. We made one more stop and then made for the farm in Algeciras. We arrived at about 3.30pm. Kiran, Zoe and Devika were already there, having arrived at around 9am the previous night. They said they had had a good journey and had no problems with their Ninety. Ian Robinson the Photojournalist had also arrived, having flown over from the UK. Ian is a very nice guy, a lot of fun and very interesting. He is writing this article for Land Rover World. This is also where we met up with Ray Monteith. Only ourselves, Jean, Paul, Zoe and Kiran had met him before, at his home in Kent. For the others it was their first meeting. We set up camp. The site had good washing and shower facilities, so everyone made the most of these. The men went and had a play on the small off-road site that was set out on the farm. Later that evening we had a Barbecue. While we were eating the group from the previous trip arrived so we all asked them guestions. Early to Bed.

#### WED 14th APRIL (Morocco. Cueta to Meknes.)

Up in the pitch dark at 6am, packing up the tent. We had a quick breakfast of bread and marmalade and a cup of coffee. Left the site a 7.15am to catch the 8 am Ferry to Cueta. Everything went to plan. We had a modern ferry which did the crossing in about 30 minutes, passing Gibraltar which was covered by a very black cloud. On arriving, there is a very small piece of land in Africa (Cueta) that is Spanish. Ray collected the support truck which he had left here. We all filled up with fuel and we also filled our jerry cans. We then crossed the road and did some last minute shopping in the local Spar before crossing the border into Africa. We went through the Spanish side of the border as easy as pie (didn't even know we had). BUT the Moroccan side well!!! That's another story, it took about 2 hours. As we leave the Spanish side we can see this rather large and imposing Eastern Arch. This is the gateway to Africa. We enter this arch and are in an area of about four vehicle widths by about 100 yds long. Down either side there are continuous buildings with various Arabic signs above "windows". There are Officials and Police everywhere. It is very intimidating. Nick said stay in the Ninety and lock the doors. You need to have ready, all the documents relating to the vehicle i.e. Registration and green card if you have

one. (Our green card only covered us in Spain not Morocco, so we also had to buy insurance at the border.) These documents must be in the passport of the vehicle owner. We had entry forms, which Ray had given us in advance, so we had been able to fill these in on the ferry on the way over. These have to be ready in the appropriate passport. There are several stages to pass through, Immigration, Customs and Police. Ray told us to stay claim and be polite. (It is all so different, even if you are quite safe you feel threatened.) The men decided to stay together in groups of two and three as they felt less intimidated that way. All the men were approached by a number of well dressed men offering to act as an agent for a fee of twenty pounds. We did not need individual agents as Ray ha an agent acting for the whole group, who would sort out any problems should they arise. Firstly, there was a visit to the Passport Control "window". Nick handed over his and my Passports and Entry Forms. They took these and disappeared into a back room for some time, while Nick just stood and waited. Eventually they were returned to him stamped. From here he went to the Money Exchange to change Sterling into Dirham. Another 20 minute wait. (If you can picture this area, I am in the Ninety in a row of vehicles pointing towards Africa. Then there is another row of vehicles pointing towards Spain. There are Officials walking up and down all the time and I am watching Nick and the others going up and down to various "windows".) By this time it was getting very hot. With the doors locked I had to open the windows a bit. After Nick had changed our Currency he had to go to another "window" to get insurance cover for the Ninety. All the time there was queuing and waiting. Once he had the insurance he had to Import the Land Rover into Morocco and yes that involved more forms, more waiting and yet more "windows". While we were waiting a Moroccan trying to enter Spain was dragged from his car, hysterical and sobbing by the Customs Men and the Police. They walked up and down with him while he was crying and waving his arms about. There was a lot of commotion with various Officials talking to this very distraught man. This scene was enacted in front of us for several minutes. Then suddenly, they patted the man on the back, escorted him back to his car and told him to drive on. It was the most bizarre thing. Later, another Moroccan queuing up at customs was kicked to the ground by these Official Men. His crime, he had jumped the queue. We saw bribes being paid to the Officials all the time. Eventually after about two very exhausting and intimidating hours we were given an Import Sticker to put on the inside of the windscreen and we were told the vehicle would then have to be searched. (To avoid the vehicle being searched i.e. emptied out on the ground, and to ease our passage through customs we had already given Ray ten pounds each to bribe the Officials.) When our turn came to be searched, we saw Ray give the Official his bribe. He quickly looked in the back of the vehicle and waved us on. What an experience!! Driving through the first streets of Morocco was a real eye opener to how 3rd World Countries live. Slum housing, a lot of rubbish in the streets it was very dirty everywhere. If you stopped the vehicle for anything, there was immediately an adult or child asking for cigarettes, sweets, clothes any item you might have that they would like. It was very intimidating. However, the further we

went to the countryside the better it got. There was not the rubbish everywhere that we had seen in the town, it became cleaner and greener. Although the people were very poor and the housing nothing more that huts, they worked very hard. They work the fields with a donkey and a wooden plough. The countryside became more and more beautiful the further we got into the Riff Mountains. The Mountains are a beautiful, a rich dark red\orange with the green of the fields and the very dark green of the trees. We had a quick stop for fuel and the loo's and then we carried on until lunch time when we stopped at a small cafe. We stopped briefly on the roadside to look across fields at the remains of a Roman Building. In the countryside we passed through villages where the houses had mud walls and thatched roofs. Along the road side the oranges are growing on the trees. There are olive groves everywhere. The richer farms in this area have an old tractor and therefore the fields are bigger. There are fields of almost ripe barley. beans, rape and a good many other crops which we do not know. There are plants of Mother-in-laws Tongue and Prickly Pear in flower (Both Giant Ones!) growing by the roadside. We arrived at the Municipal camp site at Meknes at around 4.30pm. We were all very tired. Hassan, who is Ray's Moroccan guide and assistant arrived to join the group here. The site was a good one but it makes English camp sites look fantastic. It had toilets, showers and a shop. The loo's and showers you would rather not use, so we decided not to have a shower and we only used the loo's out of necessity. We camped under big old Eucalyptus Trees. We did not explore Meknes as we will stay on the same site on the return journey. We went to bed at 9pm Moroccan time which is plus two hours on Spanish time. We seem all out of sync with the time. At 4am we were woken up by the wailing prayers of the locals. NO KIDDING! Very loud.
