## **Chairman's Comments**

Chairman's comments - January 2003

Hope that those of you who attended the Broxhead RTV/Driving Day enjoyed yourselves, and the same for the Christmas 70's revellers at Cornucopia - who is Rod Stewart anyway!?

Well, it's 2003, and HBRO has a few resolutions to deliver this year - "MORE OF EVERYTHING". It is an ambitious plan, and we may have to scale some of the goals down a little, but we are going to give it our best shot. HBRO has benefited from a number of extremely diligent and hardworking members who always step up to the challenges, and in 2003 we are hoping that these members will be joined by more members willing to help deliver the objectives. In particular, the club is seeking to increase the number of driving days and RTVs, plus add CCVT and Safari back onto the itinerary, as well as introduce more challenge style events, including Winch. In addition our normal activities including Chippy Challenge, BAMA exercises and runs to the ARC Internationals, Belgium and the regular shows will also feature. There is also an aim to run a charity event on Bagshot Heath, along the lines of the old Bagshot Show, in October, and sponsors are already being sought for this. To achieve all this, we need as much help as we can get, so don't hold back - please call or email me or any of the committee and we will make sure your enthusiasm is what makes HBRO the club to be with!

So, what's happening in January? We have a visit to the Pingewood Off-Road site near Reading for an RTV on the 12<sup>th</sup> January, followed by the BAMA Rickshaw Exercise on the 25<sup>th</sup> January. See details elsewhere in P&B.

We have now run 2 very successful Recovery training days, in association with 'Off Road Motivations', and a third is scheduled for Sunday 16<sup>th</sup> Feb. So, if now's the time to brush up on your skills, learn some new techniques and run through the safety tips please contact Nick Jennings and book your slot. It is HBRO's intention that as a responsible 'Off-Road' club, that to increase safety at events only Marshals who have been through the Recovery training will be allowed to control recovery at our events. After the 3<sup>rd</sup> training session we will have 30 members who will be able to provide this role. We will also be seeking to raise awareness of the safety issues amongst members, and Nick is looking into other training to cover general and fire marshalling. HBRO is taking the lead in the ARC on training, and we are hoping that other Clubs follow our example.

Can I ask that any members who want to put up a team for any of the inter-club events such as the "Majors" or the "War of the Roses", to please contact me before booking.

There is a continuing issue over the location of the Northern Pub meet, and so the plan is

to look for an alternative location, convenient to the Hook Junction, which has a clubroom available for HBRO use. As soon as this is resolved in association with the regular attendees at the meet, it will be publicised in the P&B, and on the HBRO website.

## Finally, a few messages:

- 1. The fees for RTV's have been increased to £14 per event, to cover the rising costs of land, insurance, permits and associated costs. We have held the fees at £12 for a long time, but it is clear that RTV's are no longer covering their costs, and therefore an increase is unavoidable. This was agreed at the AGM.

- Recovery ropes please equip your vehicle with a good quality recovery rope it
  saves time and avoids always having to use others when you do get stuck the
  club does stock several types of rope and length at very reasonable prices.

Unfortunately, many of you may have heard that Steve Kirby our Land Rover Expert extraordinaire, ARC Council member, P&B editor and mainstay of the Club since formation, has had to spend some time in hospital following a stroke. We are all hoping for a quick recovery for Steve and for his early return to the Hobby he devotes so much of his time to for the benefit of all of us fellow members of HBRO.

In the meantime, Ed and Angela have stepped up to take on the mighty challenge of editing the P&B, so **muchos gracias** go to them for adding to their already burgeoning HBRO workload.



## RTV Rules Guidance Note Rule Interpretation

**Background:** There has been some confusion over the interpretation of some of the rules and their application for RTVs. What follows is the interpretation that shall be followed at all future trials unless there is a particular amendment agreed (Supplementary Regulation) with the Clerk of the Course and Competition Secretary.

**Shunt:** A shunt is allowed for vehicles of 95" wheelbase or greater. The rule stated in the ARC green book is that a shunt (a stop/reverse/recommence manoeuvre) is only allowed when the driver is unable to negotiate a tight turn. This rule does NOT allow a restart where the vehicle could not maintain forward motion and had come to an involuntary halt. (Ref ARC Green Book Page 46 item 5.1).

Further the AWDC have clarified this by saying that it does not allow a vehicle to take a run at a hill, or through a mud run, come to a halt calling "shunt" just before stopping and then make another attempt.

We shall be applying the rule as it is intended from now on. Shunts caused by an involuntary halt or an additional attempt at a hill or such other obstacle shall not be allowed. The score given will be the next gate or the gate that has been touched.

Further a shunt must be within the driven line of the section. The vehicle shunting must have at least one wheel within the driven line.

It is acceptable for a vehicle to shunt back more than one gate.

In performing a shunt the score attained will be the lowest score achieved at the time of the shunt. So if a driver clears a 4 gate (his score now standing at 3) then is forced to shunt and subsequently hits the 4 gate or another gate with a higher score, then his score of 3 will stand. This also applies if he is unable to make the 4 gate again.

Hitting a gate that is not on the direct driven line. In this instance a driver is moving from gate 8 to gate 7, however gate 4 is close to the route between these two gates. If the driver hits gate 4 then he will score the next gate that he was heading towards. In this instance 7 would be the score.

## Recovery Marshals

As you are probably all aware safety is of a great concern to all of us, not just individually but collectively as well. **Motor sport is dangerous** and all sorts of risks come into play.

For us all one of the biggest risk situations is the recovery of a vehicle. Many risks manifest themselves; such as, failed winch ropes, broken shackle etc.

With the good offices of Nick Jennings a series of recovery management courses have been and are being run through an accredited organization.

"The Committee has agreed that in all of our competition events, and driving days, recovery situations should be managed by one of the **trained recovery marshals**. All recoveries that require the use of a winch **shall be managed** by one of the trained recovery marshals.

A recovery marshal will take charge of the situation, formulate a plan for recovery, check the condition of the recovery and manage the safe recovery of the vehicle and location of the spectators."

I would ask you all to respect the wishes of the recovery marshal. If he tells you to stand well clear please do so, he is trying to protect you.





## THE LAND ROVER MARQUE DAY and HERITAGE RUN

## 4th MAY 2003

On Sunday 4th May 2003 we shall celebrate Land Rover's 55th birthday in our now well-established way, at the Land Rover Marque Day and Heritage Motor Centre Run. The usual format will apply:

- A full day of Land Rover nostalgia and Marque Day activities at HMC.
- The Heritage Motor Centre Run will assemble at Lode Lane by 09.30 am, with the Series 1 vehicles leading off at 10.00 am, and arriving at HMC at approx. 11.00 am.
- Camping will be available on the HMC campsite on Saturday and Sunday nights.

Entry fee for the HMC Run will be £12 per vehicle, which will include entry to both the event and the Museum, for the **driver and one passenger**, plus a rally plate for the vehicle, a limited edition rally plaque, and "fast track" entry into the Centre on the Sunday. **Additional passengers** in Run vehicles will need to prebook their entry tickets at £7.00 per adult, (children 16 years and under FOC) with their Run entry.

In 2002 the Run was fully booked well before the closing date, early booking is therefore advised, as applications are accepted on a "first come first served" basis. Please also note that each vehicle class (Series I, Series II etc) is limited to a maximum of 30.

For non-Run participants attending the Land Rover Marque Day in a Land Rover product, the driver will get free entry, but all passengers must pay the Club Discount admission rate of £7.00 (children 5 yrs to 16 yrs incl. £5.00) at the paybooths. ## 3. Authorisation

## 4. Eligibility

The event is a Closed Club event and is only open to HBRO members. HBRO is affiliated to the Motor Sports Association, and is also a member of the Association of Rover Clubs (ARC) and defined by the ARC as a competitive club, (NB this also includes the Gymkhana event).

The maximum number of entries will be 60

have their entry countersigned by their parent or guardian at signing on (E2.22.2/B9.3.8) All vehicles presented for scrutineering shall be in a clean condition (E5.1.2)

Persons comprising the crew at the start of the event <u>may not</u> be varied during the event (H25.1.1)

Protective bulkheads shall be complete with all holes sealed (E12.2.3)

Additional checking of vehicle or entrant eligibility may be carried out at any time during the event

The Chief scrutineer and the Clerk of the Course and Secretary of the Meeting will be regarded as judges of fact (C11.3 –11.4)

Names of Judges of Fact and Driving Standards observers will be posted on the official notice board.

## 8. Start and finish of Competition

All vehicles will start the event from the official starting lines in group number order – allocation will be advised at signing on.

Starting sections will be in number rotational order. On finishing the event, all vehicles must return to a designated holding area. Only after instruction from the Clerk of the Course will vehicles be allowed to leave. Failure to comply with this will result in exclusion.
